# **Summary**

## **Strategic Matters**

### **CEO Report**

The Board receives a report from the AITSL Chief Executive Officer (CEO) at each meeting with key updates on the delivery of AITSL's continuing work program, including corporate matters, people and culture matters, policy and program highlights, fee-for-service and international projects, and stakeholder engagement activities.

The Board **noted** the CEO Report and had a robust discussion on planned changes to the Literacy and Numeracy Test for Initial Teacher Education Students (LANTITE) requirements.

### Strategic Risks

At each meeting, the Board receives a report on developments against strategic risks and every 12 months, the Board reviews its Strategic Risk Register and considers the key risks to be monitored for the next calendar year.

The Board reviewed and approved the draft strategic risks and appetite statements for 2024.

The following key matters were discussed:

- Cyber security is a major issue and challenge for all organisations with profound impacts.
- Cyber security along with natural disasters are the biggest threat to business continuity.

# Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability

The Board noted an update on the final report of the Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability and discussed the following:

A clear definition of inclusion needs to be developed and nationally accepted.

 A potential narrative change could focus on inclusive systems and architecture that are complementary to mainstream settings, offering a range of education options for people with disability.

# **Cultural Responsiveness**

The Board **noted** a presentation on AITSL's Indigenous Cultural Responsiveness Initiative and discussed the following key issues:

- the inclusion of First Nations' perspectives in the draft Professional Standards for Middle Leaders for the Queensland Department of Education
- engaging with other education organisations' Aboriginal and Torres Strait Islander advisory groups
- implementing and assessing the impact of the Indigenous Cultural Responsiveness Toolkit in schools.
