## Summary

#### **Strategic Matters**

#### **CEO** Report

The Board receives a report from the AITSL Chief Executive Officer (CEO) at each meeting with key updates on the delivery of AITSL's continuing work program, including corporate matters, people and culture matters, policy and program highlights, fee-for-service and international projects, and stakeholder engagement activities.

The Board had a robust discussion about standards and early childhood teachers and there was broad agreement that a short-term solution to provide guidance to early childhood teachers paired with a complete review on the broader issues is the most desirable outcome, noting that any review of the *Australian Professional Standards for Teachers* (Teacher Standards) represents a reputational risk to AITSL.

#### **AITSL Impact Measurement Strategy**

Every 6 months, the Board receives an update on the Impact Measurement Strategy containing monitoring and evaluation information for each of AITSL's programs (streams of work). The Report is not published externally but provides a mechanism for communicating impact to the Board. It includes the status of monitoring and evaluation of AITSL programs, updates on the AITSL Stakeholder Survey, and AITSL's Strategic Plan short-term success metrics.

The Board **noted** the AITSL Impact Measurement Strategy 6-Monthly Report and the update on the data provided.

#### Shortened Initial Teacher Education Programs

The Board considered a proposed policy position regarding faster and more innovative initial teacher education (ITE) pathways for consideration by the Education Minister Meeting (EMM).

The Board had a robust discussion on the issue and agreed that AITSL should have a clear, evidence-based position regarding shortened ITE programs that reaffirms the importance of the national standards.

Extensive feedback was provided by the Board to incorporated into the policy paper and resubmitted for approval.

#### **Optimal Deployment of Teaching Assistants | NTWAP Action 21**

The Board considered draft of the guidelines to support the optimal deployment of teaching assistants (TAs), developed in response to Action 21 of the National Teacher Workforce Action Plan (NTWAP) for approval to share with Schools Policy Group (SPG) and other key stakeholders for feedback.

The Board provided expertise and guidance on the role and responsibilities of TAs and intervention modelling.

The Board approved the draft guidelines, subject to the Board's feedback being addressed, to be shared with SPG and other key stakeholders, noting some feedback could be considered following SPG.

#### **Professional Standards for Middle Leaders**

The Board noted an update on the Professional Standards for Middle Leaders (Middle Leader Standards) project commissioned by the Queensland Department of Education (the Queensland Department) and proposed next steps.

#### **Expert Committee Review Strategy**

The Board considered the proposed options for the process to review the expert standing committees and discussed membership, engagement, and the committees' operational context.

The Board **agreed** to a review of the Terms of Reference and membership of both committees.
